- Title

- Training history
- IP Address
- Your first and most recent login activity
- Forum discussions and/or posts
- Certifications

This processing does not involve special category of data neither automated processing.

Purposes of data processing

The personal data will be processed for the provision of GÉANT e-Academy services and informing individual about other relevant GÉANT/ community events/trainings and initiatives, reporting to the European Commission.

Legal basis for processing

For the purposes of processing related to GÉANT e-Academy we process personal data received:

- on the basis of your legitimate interest consisting in providing you with the access to knowledge at training materials available at GÉANT e-Academy, which is not overriding your rights and freedoms.
